HEALTH GUARANTEE

Your puppy is sold to you as a healthy, happy puppy of sound temperament. He/she is the result of selective mating of quality parents with certified clearances. He/she is an excellent representative of the breed. The buyer agrees to take good and responsible care of the dog, providing adequate nutrition, shelter and medical care including annual examinations so as to ensure the physical and emotional well being of the dog.

All Maplelane puppies are sold on a complete health guarantee. Your puppy has had a complete and thorough examination by our Veterinarian, Dr. P. Lectin of Allandale Veterinary Hospital (705 733 1422), at the age of six weeks and is guaranteed to be in a good, clean state of health on departure from our home.

Your puppy is going home **NOT** vaccinated as Maplelane is following a new recommended vaccination protocol. It is the responsibility of the new owner named here in to see their veterinarian when the puppy is between 8-9 weeks for their first set of vaccinations. If at this time your veterinarian feels there are genetic issues with your new puppy and they are properly documented, you may return your puppy for a full refund, provided the puppy is in the same condition as when sold. Or the buyer will receive a replacement puppy from the next litter whelped at our home, to be decided upon by the breeder. All veterinary bills after departure from our home, no matter what the reason, including the three-week period are the responsibility of the purchaser.

MAPLELANE GOLDEN RETRIEVERS WILL PROVIDE THE FOLLOWING GUARANTEE ON EACH PUPPY SOLD FOR THE FIRST 3 YEARS:

- 1) To be of sound temperament upon departure from our home.
- 2) Free of hereditary eye cataracts.
- 3) Free of congenital heart disease, as determined by an ultrasound.
- 4) Free of hip dysplasia, as per the following terms:
 - A) The dog must not be more than 10 pounds overweight as determined by a veterinarian.
 - B) There will be no cash refund unless surgery is required and completed.

If your dog shows any of the above faults in this 3-year period, and suitable evidence has been produced, the following terms are available.

One half of the original purchase price may be returned, or a free puppy from the next available litter of the breeder's choice. In this situation, the purchaser shall keep their original puppy and all vet bills pertaining to the ailment are the responsibility of the purchaser. If a cash settlement is required, Maplelane will make payment from the income of the next litter produced. If the purchaser does not want to keep the original puppy and wants to return it, then the cash settlement becomes null and void.

If for any reason, the buyer wishes to sell, trade, donate, give away, co-own, euthanize or part with their dog at any time, will agree to notify the breeder and give the breeder first opportunity to re-purchase the dog for a negotiable sum.

NON-BREEDING CONTRACT

All puppies leaving our home do so with the knowledge that this puppy will be sold on a **Non-breeding Contract**. This will be lifted when the breeder is satisfied that the following conditions have been met.

- 1) Free of hip dysplasia as certified by OVC or OFA
- 2) Free of hereditary eye disease as certified by a canine Ophthalmologist
- 3) Thyroid and VWD blood test negative
- 4) Heart check
- 5) Obtain a CKC recognized title
- 6) To be of sound temperament and a good representative of the breed

In the case of bitches, the non-breeding contract will not be lifted before the age of 2. In males it will be lifted at 2 years.

Unless otherwise discussed with the breeder, females are to be spayed just before the second heat, and the males are to be neutered by 18 months of age.

The breeder will receive first pick puppy from the first litter for the price of one dollar.

The breeder reserves the right to use any male dog bred by them for stud service to any bitch owned by the breeder. This privilege will be supplied on a no charge basis; all expenses required will be the responsibility of the breeder. This being achieved after the lifting of the non-breeding contract and both parties are in agreement.

YOUR PROMISE TO MAPLELANE

Throughout your dog's lifetime, it is the responsibility of the purchaser to forward copies of any clearances or titles obtained, as well as any health issues, for the breeder's records.

It is critical to Maplelane's breeding program to have your input/feedback. Do not hesitate to inform us of any issues you feel could/would be helpful to our breeding program.

It should be noted that all the above guarantees, clauses and conditions are a binding agreement between the breeder and the purchaser. Any forfeiture, neglect or failure to comply on the part of either party could result in legal action being taken. In the case of the purchaser failing to adequately provide for the dog in any way as stated herein, or the breeder discovers abuse in any form, gives the breeder the right to reclaim and repossess the dog with no financial attachment.
